Terms & Conditions

This Agreement is made and entered into on _____ of _____, 2025, by and between **ARQEM LAHORE (PVT) LTD**, a company incorporated under the laws of Pakistan, with its principal place of business at 14/1 Block L Gulberg 3rd Lahore, hereinafter referred to as the "Provider," and

Pilgrim's Full Name _____, residing at **Pilgrim Address** _____
_____, hereinafter referred to as the "**Pilgrim.**"

WHEREAS, the Provider offers Hajj packages and services for pilgrims traveling to the Kingdom of Saudi Arabia (KSA); and
WHEREAS, the Pilgrim desires to engage the Provider for these services in accordance with the terms and conditions set forth herein.
NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the Parties agree as follows:

Terms and Conditions

1. Approval by Ministry of Religious Affairs (MORA)

The packages and facilities outlined in this Agreement are subject to approval by the Ministry of Religious Affairs (MORA), Government of Pakistan.

2. Compliance with Laws and Regulations

The Pilgrim shall strictly adhere to the laws and regulations of the Kingdom of Saudi Arabia (KSA) during their stay. Any violation may result in disqualification from future visits to KSA and legal action by Saudi authorities.

3. Mashair Facilities and Camp Location

- 3.1 Facilities provided during the Hajj days (8th to 13th Zill Hajja) are subject to the services and arrangements made by the appointed Moallim.
- 3.2 The camp location in Mina will be allocated by the Saudi Government and shall be acceptable to the Pilgrim.
- 3.3 Maktab category is subject to availability. In case of a change in Maktab category, any difference in cost shall be adjusted accordingly.

4. Movement to Jamarat

The Pilgrim shall travel to Jamarat in groups, adhering to the specified timings for Rammi as per Saudi Government instructions.

5. Payment Procedure for Hujjaj from Pakistan

- 5.1 The package price is calculated in Saudi Riyal (SAR). Payments made from within Pakistan shall be in Pakistani Rupee (PKR), converted at the Bank Telegraphic Transfer (TT) rate on the date of transfer to Saudi Arabia.
- 5.2 Payments shall be made by Cross Cheque, Bank Draft, or Pay Order in the name of "ARQEM LAHORE (PVT) LTD."
- 5.3 A deposit equivalent to 50% of Package Amount is due at the time of booking , with the remaining balance payable by October 15, 2025.

6. Payment Procedure for Overseas Pakistani "Sponsorship Scheme"

- 6.1 Hujjaj booked under the Sponsorship Scheme shall pay in US Dollars (USD) at the rate specified in the Hajj package.
- 6.2 Payments shall be deposited into the USD bank account provided by the Provider.
- 6.3 A deposit equivalent to 50% of Package Amount is due at the time of booking , with the remaining balance payable by October 15, 2025.

7. Payment Timeliness

Timely payment is essential for securing visas, hotel accommodations, transportation, and Mina camps. The Provider bears no responsibility for failure to secure a Maktab A Category Camp or other services due to delayed payments or market factors such as demand and supply. The Provider will make every effort to secure the requested Maktab category, but the Pilgrim must accept the available camp.

8. Hotel / Room Category and Stay Duration

- 8.1 The duration of hotel stays in Makkah or Madinah may change due to flight availability or Islamic/Gregorian calendar variations, with no refunds in such cases.
- 8.2 Hotel categories are per Saudi standards. Rooms are double/twin bed, with triple or quad bed arrangements as specific
- 8.3 All Hujjaj are accomodated in City view Standard Rooms **Triple Room** means Twin Room + one fold out bed | **Quad Room** Means Twin Room + 2 fold out bed

9. Date Changes

All dates are subject to change due to Islamic/Gregorian calendar variations, force majeure events, or changes in law or airline schedules, with no refunds in such cases.

10. Passport Submission

Failure to submit the passport by the specified date absolves the Provider of responsibility for any visa-related issues.

11. Visa Responsibility

The Provider is not responsible for delays or non-issuance of Hajj visas by the Saudi consulate. In case of "Sent to Embassy" status, a charge of PKR 30,000 will be incurred for passport handling.

12. Taxes and Additional Charges

- 12.1 The package includes 15% VAT and 5% municipal tax as per Saudi regulations. Any additional taxes imposed by authorities shall be payable by the Pilgrim.
- 12.2 Any additional charges imposed by Saudi or Pakistani authorities shall be payable by the Pilgrim.

13. Airfare

The actual market airfare will be charged as per the current system/market rate at the time of booking.

14. Luggage Policy

Luggage and baggage policies are as per the airline's regulations. Excess luggage is at the Pilgrim's risk and cost.

15. Mandatory Training and Presentations

Attendance at Hajj training sessions and presentations conducted by the Provider is mandatory for the Pilgrim.

16. Cancellation and Substitution

- 16.1 Packages are non-cancellable after Hajj application submission.
- 16.2 Substitution is permitted only as per the policies of MORA and the Saudi Government. No refunds will be issued after visa issuance or rejection of substitution.

17. Travel and Health Insurance

The Pilgrim is responsible for obtaining and maintaining their own travel and health insurance for the duration of the pilgrimage.

18. Accommodation and Transportation

The Provider shall arrange accommodation and transportation as per the package details, subject to availability and the terms of this Agreement.



Terms & Conditions

19. Itinerary Changes

The Provider reserves the right to make itinerary changes due to unforeseen circumstances, including but not limited to force majeure events, government regulations, or operational constraints.

20. Personal Conduct

The Pilgrim shall respect the cultural, religious, and legal norms of KSA throughout the pilgrimage.

21. Representation and Signing on Behalf of Family/Companions

The Pilgrim represents and warrants that they are legally authorized to enter into this Agreement on behalf of their family members or companions (the "Companions") participating in the Hajj pilgrimage under this package. The Pilgrim shall ensure that all Companions are aware of and agree to the terms and conditions of this Agreement and shall be responsible for their adherence to these terms throughout the pilgrimage.

22. Governing Law and Dispute Resolution

22.1 This Agreement shall be governed by and construed in accordance with the laws of Pakistan, without regard to its conflict of laws principles.

22.2 Any disputes arising under this Agreement shall be resolved through negotiation or, if necessary, litigation in the courts of Lahore, Pakistan.

23. Entire Agreement

This Agreement constitutes AND CHOSEN Package the entire understanding between the Parties and supersedes all prior agreements, whether written or oral. Any amendments must be in writing and signed by both Parties.

24. Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.

25. Notices

All notices under this Agreement shall be in writing and delivered to the addresses provided above via certified mail or email with confirmation of receipt.
